16.2 Description

The anchor device with fall-through protection type: ABS DomeWeb is used to temporarily protect people against falling. When using, a maximum of one person can be secured to the anchor line made of webbing. The system is installed horizontally on rooflights with sufficient load-bearing capacity.

The fall protection is specially designed to protect a person in the event of a fall through a rooflight. In addition, the person can be rescued by another person.

The fall-through protection consists of a network with dimensions of 2.0 m x 2.0 m up to 3.0 m x 3.0 m.

The system is installed on the rim of the rooflight using a webbing with a tensioning element. The webbing is looped through the mesh and fixed to the mesh with additional loops.

On the webbing, the user can directly secure himself against falling with a connecting element and his additional PPE against falls from a height.

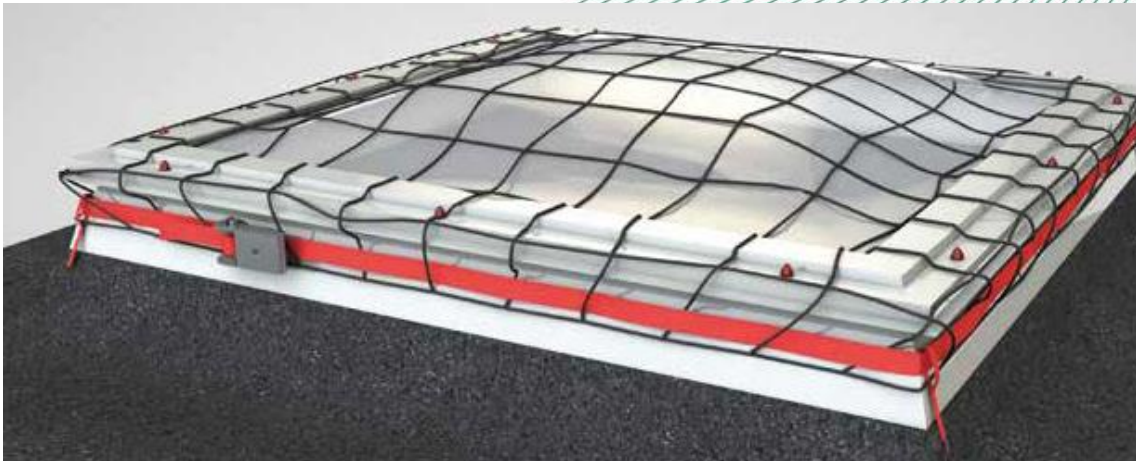


Fig. 1: Anchor device with fall-through protection, type: ABS DomeWeb
